- Protect the health and safety of my players by insisting that all of the activities under my control are conducted for their psychological and physiological welfare, rather than for the vicarious interests of adult. I will report all injuries to parents and administrators as required.
- Have two adults present at all times whenever possible.
- Return all equipment provided at the end of the season and to report any defective equipment immediately.
