Winter bill issued Dec 1 due Feb 14; postmarks not accepted

3% City penalty added after due date on tax amounts only

1% per month interest added beg Sept on tax amounts only - spread to all taxing entities

Beginning 2003 SET collected on summer bill - 1 mill reduction from 6 to 5 2003 only.

Beginning 2005 1/3 County operating collected on summer bill - 2/3 in 2006, total transfer 2009.

Beginning 2007 dedicated streelighting & roads/bridges millages elimated. Police/Fire increased

Beginning 2008 tax year MBT created - affects commercial & industrial personal.

Commercial personal exempt from up to 12 mills school operating (6 mills IFT)

Industrial personal exempt from up to 18 mills school operating (9 mills IFT)/exempt from full 6 mill SET.

Beginning 2009 City millage change - landfill millage expired; begin library millage

Beginning 2010 City millage increased voter approved 2 mills dedicated police/fire (6.262) total 9.7064
